CREDIT CARD ORDERS BY TELEPHONE:

CREDIT CARD ORDERS BY MAIL:

VISA, MASTERCARD, AMERICAN EXPRESS or DISCOVER in continental USA, Alaska, or Hawaii. Fill in all the necessary information on the order form. We can only ship to the billing address of the cardholder.

C.O.D. ORDERING:

We can ship C.O.D. for Cashier's Check or Money Order only. Most equipment except custom items, filled heavy bags, home and wall gyms, weights, weight lifting equipment, and several other "heavy" items can be shipped C.O.D. When ordering C.O.D., be sure that your order is shipped to an address where someone will be available during working hours (8am-6pm) to receive and pay for the order. Any returned C.O.D. orders will be entered into our records and all future orders will have to be pre-paid.

WESTERN UNION WIRE TRANSFERS:

For your convenience, we offer Western Union "Money Transfer." Avoid the need for C.O.D. payment! Title will receive your payment the same day you send it from your local Western Union location. Call for details.

CHECKS:

If your check is returned it may be collected electronically and you will be assessed a processing fee as allowed by law. Check writer is also responsible for all other check recovery costs, including all attorneys' fees, court costs and taxes.
